Swapnil Satam work for transgender's rights in District Legal Services Authority (under <u>National Legal Services Authority NALSA</u>). **Aarohi**, the other member from Humsafar Trust also discussed many topics related to history of transgenders in India, for example, in India's mythological scriptures, there is a mention of **Shikhandi** and **Vrihannala**. Aarohi discussed many traditions of Hijra culture in India. Also, discussion about **Devdasi** custom in India. "Hijra" word is an Arabic word which means departure or exodus.

Adv. Swapnil Satam discussed about atrocities faced during childhood to adulthood. Many times, she thought of committing suicide but made her mind not to commit suicide and live in this world gracefully, despite of transgender status. She also discussed about various problems faced while studying law. Supreme Court upheld the rights of transgenders to decide their gender and directed the Centre and State Governments to grant legal recognition to their gender identity. Students gained knowledge regarding atrocities faced by transgenders and it helped in gender sensitization. The Seminar was concluded by vote of thanks delivered by Asst. Professor Nisha Gaikwad.

REPORT OF POLICE STATION VISIT
