Skill Enhancement Policy



It is a common opinion among students during exams that there is too much to study and there is very little time. This makes time management one of the most important components which directly influence exam stress. Many students misuse the time available during exams, either to avoid studying or by underestimating the effort and time needed in tackling exams. Planning time helps students think about it strategically and, even if they have to alter their study plans, they will benefit more from having previously defined your tasks and activities.

Often, students overestimate or underestimate the amount of time that any given task may take. It is a good idea to consider how much time they take for particular tasks. To begin with, many students like to keep a diary for a week and note down an hourly description of how they have spent that day while others are last moment planner which affects their performance in exams.
